CARE Annual Survey Purpose

- To collect the most accurate and complete data on post-consumer carpet diversion and recycling, each year, in the US
- To analyze and include this information in the CARE Annual Report, in order to fulfill the requirements specified in the CARE MOU



Changes in Survey for 2010

- Request for more detailed data on diversion, reuse, recycling, energy and landfill
 - Anticipate that this information will be required for future MOU and for California AB 2398
- Elimination of some questions to simplify survey
 - i.e. post-consumer and post-industrial
 - Inventory


- 11 questions in length
- 10 minutes (if prepared)
- Signature page required



Tips for taking the survey

- Please have your data handy:
 - Volumes handled at each stage of the process
 - Collected
 - Sorted
 - Processed
 - Manufactured
 - Material Flow (see flow chart)
 - To the next step in the process
 - Reuse
 - Energy
 - Landfill
 - Etc

Finished Products

Example

A recycling business person collects 1 million lbs of post-consumer carpet. The recycler sorts and shears this material and sends it to a processor.


Along the way, some of the post-consumer carpet is reused, and some is not able to be recycled, for various reasons, and is either sent to a CAAF or a cement kiln facility, waste-to-energy, incinerator or the landfill.

The recycler tracks the amount of material as it progresses through the process.

For this example, the recyclers would answer the next questions as follows:


Collector

- Collected 1 Million lbs of post-consumer carpet, of which:
 - 900,000 lbs sent to Sorting Facility
 - 10,000 lbs were reused
 - 50,000 lbs sent to Waste-to-Energy
 - 40,000 lbs went to Landfill




Sorting

- Collected 1 Million lbs of post-consumer carpet, of which:
- 900,000 lbs sent to Sorting Facility
- 50,000 lbs sent to Waste-to-Energy
- 10,000 lbs were reused
- 40,000 lbs went to Landfill
- 900,000 lbs of post-consumer carpet was available for sorting:
- 700,000 lbs went to the First-Level Processor
- 100,000 lbs were reused
- 0 lbs went to CAAF or cement kiln
- 50,000 lbs went to waste-to-energy
- 50,000 lbs went to the landfill



First-Level Processor


- Collected 1 Million lbs of post-consumer carpet, of which:
- 900,000 lbs sent to Sorting Facility
- 50,000 lbs sent to Waste-to-Energy
- 10,000 lbs were reused
- 40,000 lbs went to Landfill
- 900,000 lbs of post-consumer carpet was available for sorting:
- 700,000 lbs went to the Processor
- 100,000 lbs were reused
- 0 lbs went to CAAF or cement kiln
- 50,000 lbs went to waste-to-energy
- 50,000 lbs went to the landfill
- 700,000 lbs of post-consumer carpet was available for Processing
- Produced 210,000 lbs of sheared material
- 100,000 lbs went to CAAF or cement kiln
- 100,000 lbs went to waste-to-energy
- 290,000 lbs went to the landfill



Manufacturer

Received 210,000 lbs of sheared material

- Manufactured 150,000 lbs of finished product
- 20,000 lbs went to another manufacturer/feed stream
- 10,000 lbs went to CAAF or cement kiln
- 10,000 lbs went to waste-to-energy
- 10,000 lbs went to incinerator
- 10,000 lbs went to the landfill



Manufacturer

- 150,000 lbs were Manufactured into product
 - □ 100,000 lbs went to Engineered Resins
 - 50,000 lbs went Molded/Extruded Products
